IMPORTANT!! Errors in entry made by YOU cannot be corrected AFTER the trial closes. Errors made by me can be corrected after closing, but if you do not notify me of the correction by the Monday before the trial there will be a \$10 cash charge for any needed error correction. PLEASE READ YOUR ENTRY CONFIRMATIONS !!!!!

This trial will be held under the current rules and regulations of the Australian Shepherd Club of America. For a complete listing of the rules, visit www.asca.org.

Through submission of entry, the competitor acknowledges that they are knowledgeable of ASCA rules and regulations, and HOTASC trial policies, including, but not limited to the following:

All healthy, trained dogs, purebred or otherwise, at least eighteen (18) months of age are eligible to compete in ASCA Agility Trials. Bitches in heat, lame, or blind dogs are ineligible for entry. Bitches that come into heat or dogs that become injured prior to the closing date may have their entry fees refunded, less \$25, pending proof from a veterinarian. Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring, must be excused from the Agility trial. Any dog which the judge feels is not in control will be excused from the Agility trial.

Any owner, handler, or spectator exhibiting poor sportsmanship or abuse towards a dog or person will be required to leave the show site for the duration of the trial, a report will be sent to ASCA and may be banned from further HOTASC events. No entry will be accepted for a dog or handler disqualified from all the ASCA programs nor anyone not in good standing with ASCA.

All dogs not jumping, 16" Vet/JH, 16"+ Vet/JH, 20, 20+, or 24 inches, or those with permanent height cards from NADAC or AKC must be measured. ASCA accepts NADAC or AKC height cards only.

No leads, collars, food, toys, etc will be allowed on the course.

All dogs must be on lead or securely crated when not in the ring. No dogs may be tied to any piece of property.

Entries must be made on the enclosed entry form. Copies may be made. Entries must be signed, complete, and paid in full to be accepted. Make all checks and money orders payable to HOTASC (Heart of Texas Australian Shepherd Club). Returned

checks do not constitute a valid entry and there will be a \$25.00 service fee on all returned checks. Entry into future trials and participation in this trial will not be allowed until all fees are paid in cash or money order. Illegible or incomplete entry forms do not constitute a valid entry.

Dog sales or puppies under eight weeks are not permitted on the trial grounds.

HOTASC, its board of directors, ASCA, management, and the property owner assume no responsibility for any loss, damage, or injury sustained by the exhibitors, owners or to any of their dogs, personal property, or children.

Directions:

From Interstate 35W, travel to exit #39, which is FM 1187/Rendon Crowley road. Travel east approx. 3 ½ miles to Stephenson-Levy road. Turn right, south, on to Stephenson-Levy road. There will be an animal clinic and a Big Country Mart at the

intersection. Travel approx. ¾ mile, and the arena will be on the west (right).

Important Information:

No catalogs will be printed. Running order lists will be posted at the ring gate. Handlers with multiple dogs will be separated as much as the class allows.

You are responsible for being present when it is your turn to run. We will not hold the ring for absent handlers.

All move up requests must be received by the trial secretary by October 5, 2010. No changes will be made after Oct 5. There will be NO move-ups offered on the weekend of the trial.

Awards: HOTASC will award strip ribbons for 1st through 4th place as well as rosettes for all qualifying runs. There may also be prizes available.

FEO (For Exhibition Only) – We will accept FEO entries. FEO entries may jump any jump height but they are not eligible for any prizes or awards. This is a non-qualifying division.

Parking – Please reserve the parking against the North side of the arena for people who are crating out of their vehicles.

Cancellation of Entries - Refund of any entry fees following cancellation requests made after the trial closing date will be at the discretion of the club.

Agility Obstacles:

The following obstacles may be used at this agility trial:

Dog Walk-slatted	Weave Poles 22" spacing
A-Frame-slatted	Teeter-totter-slatless
Double bar hurdle	Non-winged single hurdle(s)
Closed tunnel	Winged single hurdles
Open tunnel	Tire

Dogs must be registered with ASCA to have their titles tracked with ASCA. You may enter as "pending", but need to send in your registration forms to ASCA at the same time. We are not responsible for lost Qs if you do not register with ASCA in a timely manner. However, you may enter without a tracking number; you just won't be getting your Q's recorded with ASCA. ASCA Service Membership and Tracking Number Application

Beginning 1/1/2003 for non-ASCA registered dogs – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of ‘Service’ is required). ASCA membership does not need to be maintained in subsequent years. It will be the responsibility of the owner to identify to ASCA the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA qualifying legs earned from 1/1/2003 until submission of application. Please type or print clearly. Incomplete or illegible forms will be returned.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1 As used here "ASCA" means the Australian Shepherd Club of America, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees and agents.
- 1.2 Exhibitor/owner, agree to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner release ASCA (including both club officers, directors, employees, and members), HOTASC ASC (including its officers, directors, and members, and event organizing committee), Roy & Deidra Goldsmith (Rendon arena) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor /owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
